Official Rules and Regulations

NO PURCHASE NECESSARY. (A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.)
OPEN TO RESIDENTS OF WISCONSIN, AGE 18 AND OVER.

ELIGIBILITY: You must be eighteen or over to enter and win, and a legal resident currently living in Wisconsin. Employees and their immediate families of Absolutely Waterford (AW) are not eligible. By entering, entrants agree to be bound by these Official Rules, and agree to release the Sponsors and Administrators from any and all liability for injuries, losses or damages of any kind resulting from participation in this drawing.

TIMING: All entries must be received between 12:00 a.m. CST on November 1, 2019 and 11:59 p.m. CST on December 31, 2019 to be eligible to win a prize.

ENTRY: There are two ways to enter: (a) by submitting receipts from your purchases in Waterford or (b) by mailing in an entry form.

a) Submitting Receipts from your purchases in Waterford

During the entry period, submit receipts or copies of receipts for purchases made at businesses within Waterford, WI with **one** form. (The business **MUST** have a Waterford address.) For each \$10 spent on purchases at Waterford businesses, you will receive one entry into the sweepstakes. Entries may be mailed or delivered directly to Absolutely Waterford, 123 N. River St. Waterford, WI 53186. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified. Purchases made outside of a Waterford address will not be considered.

b) Free mail-in method

To enter this Sweepstakes without making a purchase, hand print your full name, street address (no P.O. Boxes), day/evening/cellular phone number (if any), email address, and date of birth on a 3"x 5" piece of paper and mail it in an envelope with proper postage to Absolutely Waterford, 'Think, Shop, Buy Local' - Mail-In Entry, 123 N. River St., Waterford, WI 53185. You will receive 1 entry into the Sweepstakes drawing. Limit: 1 entry per stamped envelope. All mail-in entries must be handwritten and must be postmarked by 12/31/19 and received by AW by 1/4/20. All entries become the exclusive property of AW and none will be acknowledged or returned. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified. See limit on entries below.
